## EUREKA LODGE # 434 MEMBERSHIP RATES FOR 2022

**INITIATION FEE:** An Initiation fee is payable by all Bargaining Unit employees hired into any 434 Shop, Plant or Office. The fee is payable at the end of any trial or probationary period and is valid in the month that day occurs. The following is the fee schedule for all employees who have completed their trial/probationary period.

**\$150** for anyone whose rate of pay upon completion of their trial/probationary period is at least \$13.00 per hour.

**\$300** for anyone whose rate of pay upon completion of their trial/probationary period is at least \$15.00 per hour.

**\$500** for anyone whose rate of pay upon completion of their trial/probationary period is at least \$18.00 per hour.

### MEMBERS HOURLY RATE OF PAY MUST BE ON MONTHLY UNION DUES CHECK-OFF REPORT.

#### MONTHLY DUES STRUCTURE:

<b>APPLIED DUES</b>	<b>2 ½ times your hourly rate + \$1.00/Month</b>
<b>MINIMUM DUES</b>	<b>\$55.00/Month</b>
<b>OUT OF WORK DUES</b>	<b>\$5.00/Month</b>
<b>HONORARY WITHDRAWAL</b>	<b>\$2.00</b>
<b>RETIREMENT CARD</b>	<b>\$15.00</b>

All initiation fees, out of work dues, withdrawal card fees or any fee due to Eureka Lodge # 434 that are **NOT** deducted and remitted by an employer, are to be remitted to Eureka Lodge 434 by the member affected by such fees. **ANY AND ALL FEES REMITTED TO EUREKA LODGE 434 MUST BE MADE BY CHECK OR MONEY ORDER ONLY!**
