MEMBERS OUT OF WORK MUST REPORT THEY ARE UNEMPLOYED OR SICK OR DISABLED ANY TIME WITHIN A TWO MONTH PERIOD. OUT OF WORK DUES ARE 6.00 PER MONTH AND AVAILABLE ONLY IF PAID DURING THE TERM OF UNEMPLOYMENT AND WITHIN THE TWO MONTH LIMIT FOR THE PAYMENT OF DUES. FULL DUES MUST BE PAID IF OUT OF WORK DUES ARE NOT PAID WHILE UNEMPLOYED. ANY CHANGE OF JOB OR HOME ADDRESS MUST BE REPORTED TO THE LODGE OFFICE.

GOOD STANDING MEMBERSHIP - A member is in good standing when he or she will have paid in full the initiation fee, have no past delinquencies and be current in the payment of monthly dues. Any member who is two (2) months behind in the payment of dues is automatically "lapsed" and loses his or her good standing membership. Any member who no longer has good standing membership is subject to termination. Reinstatement to good standing membership requires payment of a Reinstatement Fee - currently \$150 for all classifications. No exception to these rules.
